

Usage of customer-owned tracking devices onboard of Lufthansa Cargo and Lufthansa Group Airlines flights

General

Lufthansa Cargo and the airlines of the Lufthansa Group, Lufthansa, Austrian Airlines, Swiss Brussels Airlines and Aerologic, allow the usage of certain Customer-owned Cargo Tracking Devices being sent along with their shipments on our global network.

Please note that if a device has been approved by Lufthansa Cargo, this approval is valid for all Lufthansa as well as Lufthansa Cargo flights and also for all SN Brussels, Discover Airlines, Sun Express, ITA Airways and Air Dolomiti flights.

Cargo Tracking Devices are Personal Electronic Devices (PED) attached to or transported in airfreight with the purpose of monitoring location and/or various parameters, such as temperature, vibration, humidity. The device may transmit these parameters remotely by means of radio frequency emissions. Devices that do not actively transmit data are defined as “loggers” and subject to the same regulations.

As all of these devices remain switched on during flight, a technical evaluation by the operator is required. Data transmission must be suspended and disabled during flight in order to comply to air safety regulations.

Non-intentionally transmitting devices powered by coin cells are per EASA AIR OPS GM1 CAT.GEN.MPA.140 (b) in a switched-off status – and are therefore permitted for usage on the Lufthansa Group Fleet without further assessment.

According to the new ICAO rules, trackers are now* allowed if the batteries do not exceed a lithium content of 0.3 grams. In addition, an output of 2.7 watt hours (Wh) must not be exceeded. The devices must still be protected from damage. All these criteria apply to common batteries such as CR2032 button cells, which are used in AirTags or comparable trackers.

Guideline

The following listed devices are accepted to be used aboard our airlines as depicted. The devices are not approved for transportation on interline routings with other carriers. Lufthansa Cargo and Lufthansa Group airlines will not be responsible for damages or losses of any tracking device in transit.

Lufthansa Cargo and Lufthansa Group airlines are constantly assessing new cargo tracking devices for usage aboard their aircraft and will update its list of approved devices here.

Concessions to use the listed devices are based upon current provisions and can be revoked at any time.

Kindly observe following general guidelines concerning your cargo tracking devices:

- Tracking devices have to be maintained in a good and safe condition in order to avoid a modification to its emission characterization and to avoid a fire hazard through its batteries
- Consider IATA guidelines „Battery powered Tracker”
- New devices can only be approved prior to technical assessment of Lufthansa Cargo and Lufthansa Group airlines
- Hard- and software changes on already approved devices have to be reported to local sales
- All devices must be securely enclosed within the shipment
