General Charges

This section contains charges valid for LCAG world-wide unless otherwise specified. In addition, observe country specific charges.

Charges Correction Advice (CCA)

Lufthansa Cargo will charge a fee of EUR 50 (USD 50) or equivalent in local currency for each Completion of CCA per CCA after acceptance of shipment, if no exception is mentioned in the special country information.

Disbursements

Disbursements do not include airfreight, fuel and security surcharge.

Disbursement fee is to be calculated at origin and must be entered on the AWB as an amount due carrier in the "Other charges" box.

Lufthansa Cargo will charge a Disbursement Fee for most ECAA countries. If the amount of the Disbursement Fee is not included in country specific information as shown in section 8.3 of Lufthansa Cargo AG TACT rules, please contact your local Lufthansa Cargo AG representative to request the applicable disbursement fee amount.

Airfreight Surcharge

Where applicable, Lufthansa Cargo will charge an airfreight surcharge on all export shipments.

Proof of Delivery (POD) & Landing Certificate (LC)

Unless otherwise specified, a standard charge for Proof of Delivery (POD) of EUR 30 / for Landing Certificate (LC) of EUR 35 or equivalent local currency applies if no exception is mentioned in the special country information.

Demurrage, Damage Fee and Non-Return Value of ULD

- a. I) A demurrage fee for **IATA-Members (Airlines)** as per table below will be charged **after 5 days** (including Saturday, Sunday and public holidays) starting at midnight of the day of release. From then on every further day or part thereof will be charged as a full day.
- II) A demurrage fee for **non IATA-Members** as per table below will be charged **from the first day on** (including Saturday, Sunday and public holidays) starting at midnight of the day of release. From then on every further day or part thereof will be charged as a full day.
- III) A demurrage fee for **forwarder and agents** as per table below will be charged **after 8 days** (including Saturday, Sunday and public holidays) starting at midnight of the day of release. From then on every further day or part thereof will be charged as a full day.
- b. The Non-Return Value per table below will be charged if a ULD is not returned within 180 days or if it is damaged beyond repair.
- c. All nets delivered along with ULD are regarded as an integral part of such unit and if missing upon return will be charged for as per table below under d.

Charges Collect

General

Carrier will decline to transport the following on a charges collect basis unless advance arrangements have been made (in addition to IATA TACT Country Rules 7.2.1. Note and 7.2.2. / 7.2.3.):

- Shipments to persons restrained of their liberty

- Shipments addressed to government agencies, except when shipped by government agents presenting proper credentials
- Shipments not equal in resale to transportation charges
- Cool shipments are not accepted on CC-basis
- Shipments on LH-AWB where one or more transportation segment(s) are booked on any Joint Venture Partner e.g. ANA
- Live Human Organ (LHO) shipments

List of Payment Facilities

Provided that charges collect shipments from the below listed countries to Germany are covered by a Lufthansa Cargo AWB and last/delivering carrier is LH, no charges collect fee will be levied:

Argentina, Brazil, Cuba, Dominican Republic, Ecuador, Egypt, Eritrea, Ethiopia, Honduras, India, Iran, Iraq, Kenya, Libya, Nepal, Nigeria, Sudan, Syria and Venezuela.

Collect is not allowed for Consolidation Shipment's to Brazil.

Collect to Brazil for nonconsolidation shipments is acceptable under the condition that all other charges must be declared as prepaid.

Security Regulations

For shipments not delivered according to local security regulations, an additional Security Fee for screening of cargo may apply. For more details, please contact your local sales representative.

Fee for written statements in more than one language

If a statement is required in more than one language a fee of EUR 50 applies.

Documentation Charges

Manual Booking Fee

Starting with 28th of October 2018 Lufthansa Cargo will charge a manual booking fee of EUR 12 (ex Germany and Eurozone) respectively USD 12/ CAD 15 (ex AO, BR, IL, KE, MX, PA, TR, UY, US) or equivalent of EUR 12 in local currency per Air Waybill for all e-bookable td.Flash and td.Pro bookings initially processed by the Lufthansa Cargo Customer Service or Service Center. For precise local currency amount please contact your local sales agent.

Booking Charge for td.Basic

For our product td.Basic, Lufthansa Cargo will invoice a charge for the following cases:

1. A booked and confirmed shipment is not delivered "Ready for Carriage" (R4C) to Lufthansa Cargo by the defined and agreed "Latest Acceptance Time" (LAT)
2. Cancellation or deletion of the confirmed booking.
3. Update of origin, destination, LAT or product after confirmed booking.
4. The shipment weight is reduced by more than 25% based on chargeable weight of the initial booking compared to the latest chargeable weight.

The booking charge is calculated based on initial or latest chargeable weight, whichever is the higher. The booking charge is only charged once per booking. In case of more than one update or a combination of above mentioned updates, Lufthansa Cargo will charge the highest amount.

Manual Entry and Electronic Transmission of MAWB Data

1. Amendment of Air Waybill and completion of Charges Correction Advice (CCA)

Lufthansa Cargo requires correctly issued AWB upon acceptance. In case Lufthansa Cargo discovers the AWB to be incorrect a correction process can be started by Lufthansa Cargo, provided this process is in accordance with local regulations and/or IATA regulations. A fee of EUR 50 per amendment /CCA will be invoiced, unless otherwise stated in 7 Special Country Information or in local agreements or regulations.

2. If Lufthansa Cargo has not received an electronic MAWB data originally from the agent (via FWB or eAWB Data Capture tool accessible through Lufthansa Cargo eServices) or it has been rejected and a manual data capture is being done at goods acceptance, a fee of USD 12/ CAD 15 (departing from AO, BR, IL, KE, MX, PA, TR, UY, US) respectively EUR 12 (departing from Euro zone) or the corresponding amount of EUR 12 in local currency applies per AWB. For precise local currency amount please contact your local sales agent.
3. If Lufthansa Cargo has received a shipment as non-eAWB from the agent, a "Paper AWB Fee" of USD 12/ CAD 15 (departing from AO, BR, IL, KE, MX, PA, TR, UY, US) respectively EUR 12 (departing from Euro zone) or the corresponding amount of EUR 12 in local currency applies per AWB. For precise local currency amount please contact your local sales agent. For a shipment to count as an eAWB shipment forwarders must have signed the IATA Multilateral agreement, be activated for eAWB by Lufthansa Cargo and transmit eAWB special codes EAP or EAW via FWB or Booking.

Manual Entry and Electronic Transmission of HAWB Data

Lufthansa Cargo needs HAWB data for all consolidated shipment worldwide to comply with national and international laws, and regulations.

Lufthansa Cargo will enter these data itself if it is only available in hard-copy form (HAWB, HAWB manifest).

1. Electronic data transmission using FHL messages via an EDI provider*

For HAWB data sent to Lufthansa Cargo using this method, Lufthansa Cargo will invoice a fee of **EUR 1.00** per HAWB (or the corresponding amount in local currency). This will continue to be itemized as a total charge on the master air waybill under "Other Charges" using charge code "CG." For all HAWBs with Origin North-, Central- or South America, the fee amount will be

2. **Manual transmission of HAWB manifest or paper copies of HAWB** or manual correction of electronically entered data for manual transmission of HAWBs or manual correction of electronically entered data by Lufthansa Cargo, Lufthansa Cargo will invoice a fee of EUR 12 EUR (USD 12 for all HAWB Origins in USA, Mexico, Central- and South America) per HAWB (or the corresponding amount in local currency) and CAD 15 for HAWB with origins in Canada. This will continue to be itemized as a total charge on the master Air Waybill under "Other Charges" using charge code "CC." At stations where due to the local cost structure the General Handling Agent charges a higher fee for manual capture, this fee will be applicable.

In both cases, Customers must additionally provide the following documents along with the Master air waybill (MAWB). These documents must be accessible for Lufthansa Cargo (for instance, in a separate envelope addressed to Lufthansa Cargo):

- a. HAWB manifest and/or a copy of the individual HAWBs
- b. HAWB manifest per pallet (if shipment consists of several pallets)

In case of eHM shipments, no paper House Manifest must be provided by customer. Instead all FHL data must be transmitted electronically to LH Cargo. The sum of all FHL messages for all HAWB belonging to one MAWB, which are electronically submitted to Lufthansa Cargo, constitutes the electronic House Manifest (eHM) / electronic consolidation manifest/list.

Customers have to ensure that:

- all consignments with at least one HAWB carry the remark "Consolidation as per attached manifest" or "Consolidation" on the MAWB under "Nature and Quantity of Goods."
- the "Consolidated Shipment" check box in the Basic Booking Information screen (BBI) is marked in eBooking all master air waybills, HAWBs and the HAWB manifest or FHL data contain the exact description of goods as well as the addresses of both shipper and consignee along with their names, street addresses, postal codes, cities and countries.

Transportation Charges for Dangerous Goods (Care)

Lufthansa Cargo charges a DGR Check Fee for all kinds of dangerous goods. The amount of the Check Fee is dependent on the country of export and the respective IATA-classification of the shipment. In addition, the number of pieces or the UN-Numbers included influence the amount of the Check Fee. For Care shipments that cannot be accepted the first time (not ready for carriage) and need to be checked again, a DGR Re-Check Fee applies. For radioactive shipments, an additional Radioactive Fee applies on top of the DGR Check Fee.

Remarks:

- The DGR Check Fee per UN/ID number/piece as well as the DGR Re-Check Fee per piece is only applicable for the DGR pieces of the shipment, not the non-DGR pieces.
- Check Fee for Dry Ice: If ICE is contained in a Care shipment, no additional Check Fee for ICE is charged.

Transportation Charges for Perishables and Temperature Sensitive Goods (Fresh and Cool)

Veterinary Inspection Fee

A veterinary check is required for food products from animal origin (see below) when entering the EU at Point of Entry (POE) in Germany/Austria (e.g. FRA/MUC/VIE).

For shipments to/via MUC please check Germany, Charges at GSK MUC.

The inspection fees cover shipment-, documentary and identity checks (by Veterinary Border Inspection Post) at first Point of Entry (POE) and have to be charged as other charges due carrier (charge code: **PM** - PER Goods 'Products derived from animals'). Only if final destination is the same as POE into Germany/Austria (e.g. FRA, MUC, VIE), the fees have to be paid by consignee upon import delivery:

The given fee below is a basic fee, additional charges may apply (e.g. extra fee during week-end, laboratory cost). Additional charges will be debited to the customer (export agent):

Phyto-sanitary Inspection Fee/Movement Certificate

A phyto-sanitary check is required for certain plants and plant products (see below) when entering the EU at **Point of Entry (POE)** in Germany/Austria if shipment is local import at POE or if shipment is forwarded on truck to final destination in Germany/EU. A check is not required if shipment will be forwarded by air to final destination in Germany/EU.

Fee for phyto-sanitary check covers the shipment-, documentary and identity check (by Plant Protection Agency) at 1st POE in Germany/Austria.

If shipment is forwarded on truck from 1st POE in Germany/Austria to final destination in Germany/EU, inspection fee has to be charged as other charges due carrier. Charge code: PF - PER Goods 'Fruit and Plants'. If shipment is local import at POE, i.e. the final destination is the same as POE (e.g. FRA, MUC, VIE), the fee is paid by consignee upon import delivery.

A no-return value will be charged if a Passive Packaging is declared lost or if a Passive Packaging is returned damaged beyond repair. A Passive Packaging will be declared lost if it has not been returned 30 days after the planned end of lease unless the lessee advises otherwise (e.g. customs hold ups). A lost Passive Packaging will be charged to the lessee with the no-return value as defined below. Should a lost Passive Packaging be retrieved and returned to the supplier, the supplier will refund its no-return value as paid by lessee deducted by 25% for 1-60 days declared as lost, deducted by 50% for more than 60 days lost. The Passive Packaging is only declared as lost upon lessee's confirmation. The lease ends with the notification of lessee that a Passive Packaging is lost.
